Provides one Aircraft Maintenance Hangar Facility for the MOARNG that supports multipurpose space for the maintenance, repair, and major overhaul of military aircraft for all Midwest states. Modernization	Procure 6 x F-35 Aircraft	HAF supported procuring 48 F-35 aircraft/year into the 2030s to modernize the USAF fighter force to support the NDS, which is what Lockheed Martin can produce for the USAF. Due to fiscal constraints, USAF was not able to procure the full 48 F-35s in FY25. These additional 6 F-35s will complete the planned F-35 procurement of 48 for FY25 and completes the build of a sustainable ANG fleet of 5 combat squadrons for increased capacity in INDOPACOM theater, plus builds one ANG FTU squadron.	\$660M	3010 AF Proc
NDS Implementation	7 New State Partnership Program Partners	CNGB FY25 PDM reclama requested \$30M (FY25-29) + \$1M partnership/yr. Result was OSD add of \$146M FY25-29 (\$25M in FY25) but nothing for new partnerships. OSD directed addition of 7 new partnerships in Jan 2024. The \$4.3M FY25 UPL requests O&M funding for new partnership signing ceremony, initial key leader engagements, SME exchanges and P&A funding for BAO cost & pre-deployment training TDY.
