BLUF: President Biden released the FY23 President's Budget on March 28th, 2022.

Provisions cited below are requests only and do not equal final authorizations or funding.

Summary funding: The president's budget requests \$773B for the Department of Defense (DoD). This is an increase of 5.75%, or \$44.5B above FY22 enacted levels. The late release of the President's Budget was due, in-part, to the extremely late FY22 appropriations legislation in which the federal government operated under a continuing resolution for the first six months of FY22. This has caused a cascading effect on the rest of the cycle, delaying normal FY23 NDAA and appropriations processes.

Army National Guard

- Requests funding for ARNG end strength at 336,000 soldiers
- \$693.8M for modernization of 35 AH-64 Apache Block IIIA helicopters for the Army
 24 aircraft designated for the ARNG
- No request for AH-64 Apache Block IIIB new-build helicopters for the Army or ARNG
- \$718.5M for 25 UH-60M Black Hawk helicopters for the Army National Guard
- \$178.6M for 28 UH-60 Black Hawk L and V model helicopters for the ARNG
- \$187.9M for 6 CH-47 Chinook helicopters for the Army
 - No aircraft designated for the ARNG
- \$307.4M for the Abrams Upgrade Program to modernize 21 M1 Abrams tanks for the ARNG
- \$493M for 27 Paladin Integrated Management Systems for the Army
 - 13 designated for the ARNG

- \$703.1M for 2,909 Joint Light Tactical Vehicles (JLTVs) for the Army
- \$297.2M for ARNG military construction (MILCON), includes requested funding for projects in 13 states and Puerto Rico
- Maintains 27 ARNG Brigade Combat Teams (BCTs), 8 Combat Aviation Brigades (CABs) and 2 Theater Aviation Brigades
- The Army will conduct 20 brigade-level Combat Training Center (CTC) rotations in FY22

Air National Guard

- Requests funding for ANG end strength at 108,400 airmen
- \$3.9B for 33 F-35A Lightning II aircraft for the Air Force
 - No aircraft designated for the ANG
- \$2.7B for 24 F-15EX aircraft for the Air Force
 - No aircraft designated for the ANG
- \$2.7B for 15 KC-46A Pegasus aircraft for the Air Force
 - No aircraft designated for the ANG
- \$707M for 10 HH-60W Combat Rescue Helicopters for the Air Force
- \$148.8M for ANG MILCON, includes requested funding for projects in 5 states
- Reduces ANG Combat Coded Squadrons from 21 (FY21) to 20 (FY22) and reduces ANG TAI from 1,010 to 1,014
 - Air Force documentation cites divestment of 42 A-10s, 48 F-15C/Ds, 47 F-16C/Ds, 32 KC-135/KC-10s, 4 E-8 JSTARS, and 8 C-130Hs

Joint-Personnel

- Requests a 4.6 percent military and civilian personnel pay raise
 - 1.9 percent more than FY21 levels
- \$96.9M for the National Guard Counter-drug program
- \$5.6M for National Guard Counter-Drug Schools
